Utilizing smaller, lightweight cars takes on all the excitement of a full-sized Figure "8" without likely danger to the drivers. Speeds average between 5 and 15 miles an hour and only 5 to 8 cars are allowed at a time. Unlike the traditional brute-force demo, in this event it is your ability to out-think and out-maneuver the other driver that makes you the **WINNER!**

PROGRAM OF EVENTS

QUALIFYING EVENTS #1-#8: In each of these events, the "Winner" (first car to cross the finish line after a pre-determined number of laps), will receive \$50, a trophy, and will qualify to run in the Feature Championship Event.
CHAMPIONSHIP FEATURE EVENT #9: Open to the drivers and their cars that qualified in the Qualifying Events. The winner will receive \$500 and the Championship Trophy.
COMPACT DEMO DERBY CHAMPIONSHIP – EVENT #10: Open to all drivers and their Figure "8" cars that competed in the above events. The "Winner" (last car running) will receive \$300, and the Championship Trophy.

THE FOLLOWING FIGURE 8 RULES SUPERSEDE THE OFFICIAL RULES FOR BATTERIES:

You will be permitted to change the location of the battery, providing you accomplish this in a manner approved by a Motor Sport Race Sanctioning Body's Rules. Battery will also be permitted inside the car provided it is secured and completely covered.

2. Avoid \$25 Entry Fee at Pit Gate and enter early!

9. PIT GATE: You may enter Fairgrounds off Route 108, turn right on Bodziach Road follow pit gate signs to gate 4. Figure 8 Pit Gate will be open between the hours of 5:30 PM - 6:30 PM ONLY! Cars entering LATE will not be allowed to compete.

CAR REMOVAL: All cars must be removed by 12:00 (Midnight). J. R. ’S TRUCK AND AUTO SALES will be purchasing vehicles the night of the event.

JM PRODUCTIONS STOCK DEMOLITION DERBY RULES WILL APPLY. HOWEVER, IF YOU WANT TO MAKE CHANGES, THE FOLLOWING EXCEPTIONS/CHANGES WILL BE PERMITTED.

1980 and newer vehicles only will be permitted to run. You will be permitted to change the location of the fuel tank and battery, providing you accomplish this in a manner approved by a Motor Sport Race Sanctioning Body’s Rules. The fuel tank recommendation by JM Productions is a stock gas tank in stock position, NASCAR approved fuel cell, or a U.S. Coast Guard Marine fuel tank, installed behind a firewall.

- Drivers may use an “approved inside gas tank”.
- If you choose to use an inside gas tank:
 - A marine-type gas tank is highly recommended. A plastic marine tank will be permitted--*provided*—it is installed in a solid steel box -- only the top may remain open, for inspection.
 - No electric fuel pumps, stock tanks or gas cans are permitted inside the driver’s compartment!
 - Only 3 gallons of gas will be permitted.
 - Gas tank must be securely fastened and covered in the trunk area over the rear end housing or in the center area vacated by the rear seat.
 - A firewall is mandatory.
 - No rubber hold-downs are permitted.
 - The gas line must run underneath the car.
 - All fittings must be leak proof.
 - Stock gas tanks must be removed if you are installing an inside gas tank.
- Battery will also be permitted inside the car *provided* it is secured and completely covered.
- Transmission: shifter can be relocated and altered, no straight rods, (must have a curled or T end) all holes must be covered. Transmission cooler may be used providing, it is secured under the hood/body.
- Differential: May be modified.
- Exhaust: Stacks will be permitted providing they extend above the hood no more than 16 INCHES. Car appearance must remain stock, do nothing more than permitted. No extra welding, no interior seam welding, no cutting, rolling or smashing.
