<b>2:00 PM SHOW • PURSE \$4,200</b>	
<b>QUALIFYING EVENT #1</b>	Drivers who have never participated in a demolition derby before.
<b>QUALIFYING EVENTS #2 &amp; #3</b>	Drivers who have participated in previous demolition derbies.
<b>QUALIFYING EVENT #4</b>	All former event "Winners" and County Fair Champions within the last 5 years.
	The last 3 cars running in each of the above events will receive \$200, a trophy, and will compete in the "Feature Event", provided they compete in the same car in which they qualified.
<b>FEATURE EVENT #5</b>	Open to the 12 drivers/cars from the first 4 events. "Winner" receives \$1,000 and the Championship Trophy; "Second Place" receives \$300 and a trophy; "Third Place" receives \$100 and a trophy. The afternoon "Winner" may NOT compete in the 7:00 pm show. The "Winner" of the afternoon show will be refunded any evening entry fee paid. Also, if you enter a fresh car in both shows and you win the afternoon show, special provisions will be made to return the fresh evening car. All other drivers may re-enter their wrecked cars for Event #5 in the 7:00 pm show.

**THE FEATURE WINNING CAR FROM THE 2:00 & 7:00 PM SHOW:** less seat belts, safety equipment, chains and battery will become the sole property of JM Productions, Inc. immediately following each Championship Event and shall be under official protest for rule compliance by JM Productions, Inc. and will not be returned to the owner.

**New York State Championship Event:** The "First Place Winner" in the Championship Events in the afternoon and evening shows will represent the America's Fair at the New York State Fair Demolition Derby Championship on Monday, September 6<sup>th</sup> at 5:00 pm in Syracuse.

<b>QUALIFYING EVENT #1</b>	Drivers who have never participated in a demolition derby before.
<b>QUALIFYING EVENTS #2 &amp; #3</b>	Drivers who have participated in previous demolition derbies.
<b>QUALIFYING EVENT #4</b>	All former event "Winners" and County Fair Champions within the last 5 years.
<b>QUALIFYING EVENT #5</b>	Afternoon non-winning drivers and cars.
	The last 3 cars running in each of the above events will receive \$200 and a trophy and will compete in the "Feature Event" provided they compete in the same car in which they qualified.
<b>"FEATURE EVENT" #6</b>	Open to the 15 cars from qualifying events #1 through #5. "Winner" receives \$1,000 and the Championship Trophy; "Second Place" receives \$300 and a trophy; "Third Place" receives \$100 and a trophy.

**BEST APPEARING CAR** - In each qualifying event, afternoon and evening, (except 5<sup>th</sup> heat in the evening show) \$100 and a trophy will be awarded. "The Best Appearing Car" is judged on colorful, fine-detailed painting, graphics or appearance/ originality. Cardboard is permitted. No metal, wood or plastic materials will be permitted. All finalists judged on audience applause.

**ALL cars must have a fresh paint job (by brush or spray.)** Cars with objectionable slogans or lettering will NOT be permitted to compete, even after slogans are removed. NO refunds will be issued.

**ATTENTION DRIVERS: PLEASE READ THE ATTACHED DEMOLITION DERBY RULES AND REGULATIONS FOR 2010 VERY CAREFULLY AND DO NOTHING MORE THAN PERMITTED.**

**PIT INFORMATION:**

- All “Non-Winners” of the afternoon show will have a “second chance” to run in the evening show’s 5th event. You must pay a \$20 entry fee and purchase an evening pit pass following the afternoon show. Car must pass full inspection by JM Productions to compete.
- Extra parts, paint and tools will be permitted in the infield. Please see your acceptance letter for further information.
- Gas can/gasoline will **NOT** be permitted in the infield or pit area. All event “Winners” will be supplied with gasoline to compete in the Championship Event.
- All drivers and pit crew will be permitted to exit the infield and go into the Fair. Drivers competing at 2:00 pm must return to the infield at 1:00 pm for a Driver’s Meeting. Drivers competing at the 7:00 pm show must return to the infield at 6:00 pm for a Driver’s Meeting. If you are not present at the meeting, you will forfeit your car, registration and all entry fees.
- Pit Passes (\$20): The driver and all crew members must purchase a pit pass, which is for participant medical insurance.
- You must be 16 years old to enter the pits. Anyone under the age of 18 must sign a Minor’s Release with a parent or guardian during the pit gate hours.

**ACCEPTANCE:**

- These events are based on previous car appearance, performance and driver’s previous aggressiveness to compete without teamwork and previous compliance of the Official Rules and Regulations. Entries not accepted will be notified and entry fee refunded within 7 days of receipt.

- After we receive and accept your entry, you will receive an acceptance letter assigning your car number, door color and event. There will be NO refunds. The first 60 entries received for each show will be assigned the show of their choice. After that, you must compete in the show selected by JM Productions, Inc. The first 15 entries received for qualifying events 2, 3 and 4 will be assigned based on experience. After that, you must compete in the event selected by JM Productions.
- Send your entry, and certified check, money order or business check made payable to JM Productions, 4751 Southwestern Boulevard, Hamburg, New York 14075.
- **PERSONAL CHECKS ARE NOT ACCEPTED AND WILL BE RETURNED WITHOUT ACCEPTANCE.**
- **ATTENTION DRIVERS: Do NOT bring your entry to the Fair or to our office. All entries must be MAILED to JM Productions and postmarked by entry deadline of August 17<sup>th</sup>, 2010. If late entries are accepted the entry fee will be \$40! Do not send entries via Federal Express, UPS, certified/registered mail or any other way that will require a signature upon delivery.**

**TOWING AND CAR REMOVAL INFORMATION:**

- Demolition Derby Cars: South Buffalo Auto Parts will be paying 50 – 75% of scrap value for your vehicle.
- If you decide not to sell your vehicle to South Buffalo Auto Parts, it must be removed from the fairgrounds property on Monday, August 23<sup>rd</sup>, between 5 pm – 8 pm. Drivers only who register the vehicle with JM Productions will be permitted to exit with their vehicle. Picture ID and JMP vehicle removal letter will be required. All Demolition Derby vehicles must be on a **FLATBED TRUCK, SOLID DECK (no opening) FLATBED TRAILER** or in an **ENCLOSED TRAILER** to exit the Fairgrounds. All drivers must remove all loose materials from the car before exiting the fairgrounds.

- If your car is a 1973 or newer you must present the title at sign-in or sign a New York State document stating you are the owner of the vehicle. The towing contractor will supply this document.

**JMP NEAT LEGAL TRICKS:**

- Move battery next to the firewall (heater box area).
- Replace 2-feet of metal gas line next to gas tank with a rubber hose and clamps.
- Spray spark plugs/wires (distributor cap) with spray ignition waterproofing and cover distributor with a baggie.
- Move any electrical boxes in grill area to the firewall.
- Cut transmission cooler lines at transmission and join them together (hose and clamps).
- Pad driver’s door (inside) with foam from rear seat cushion.
