## ENTRY INFORMATION FOR DEMO & FIGURE 8:

- Entry Fee:** (see each entry form) made payable to JM Productions, Inc. Must be a Money Order, Bank Draft or Business Check. – **NO PERSONAL CHECKS!**

- Pit Passes:** (\$20) - Driver and all crew members must purchase a Pit Pass for Participant Medical Insurance at the Pit Gate.
- Age Requirements:** You must be 16 years old to enter the pits. Anyone under the age of 18 must sign a Minor's Release with a parent or guardian during the pit gate hours.
- Pit Gate/Hours:** From Route 3, take exit 12 (Route 139), 3 1/2 miles East, to Route 3A North. The Fairgrounds are located 1/4 mile on the right. Please enter through Pit Gate "A" from 4:00 PM to 6:00 PM for all Events. **NO EXCEPTIONS!!**
- Drivers may enter a car in each qualifying event.
- CAR REMOVAL:** All cars **MUST** be removed from the Fairgrounds property within 1 hour after the last Demolition Derby/Figure "8" car is towed off the racetrack in the FINAL EVENT. All remaining cars will become the property of the towing contractor.
- Drivers only may remove their car(s) they register at the pit gate. Picture ID and acceptance letter will be required (see exception).

Utilizing smaller, lightweight cars takes on all the excitement of a full-sized Figure "8" without likely danger to the drivers. Speeds average between 5 and 15 miles an hour and only 5 to 8 cars are allowed at a time. Unlike the traditional brute-force demo, in this event it is your ability to out-think and out-manuever the other driver that makes you the WINNER!

**MONDAY/AUGUST 23<sup>rd</sup> at 7:00 PM**

- ☆ Car numbers and heats are determined by postmark date.
- ☆ Drivers will receive an acceptance letter which will state CAR # and HEAT #.
- ☆ All Double Figure 8 entries must be mailed to: JM Productions, Inc. 4751 Southwestern Blvd., Hamburg, NY 14075 to guarantee acceptance. Avoid late Entry Fee at Pit Gate and enter early!
- ☆ Entries for August 28<sup>th</sup> event, (second show) will not be accepted until we have enough cars entered in the August 23<sup>rd</sup> event, (first show) unless you are entering both shows.

**JMP NEAT LEGAL TRICKS:**

- Move battery next to the firewall (heater box area).
- Replace 2-feet of metal gas line next to gas tank with a rubber hose and clamps.
- Spray spark plugs/wires (distributor cap) with spray ignition waterproofing and cover distributor with a baggie.
- Move any electrical boxes in grill area to the firewall.
- Cut transmission cooler lines at transmission and join them together (hose and clamps).
- Pad driver's door (inside) with foam from rear seat cushion.

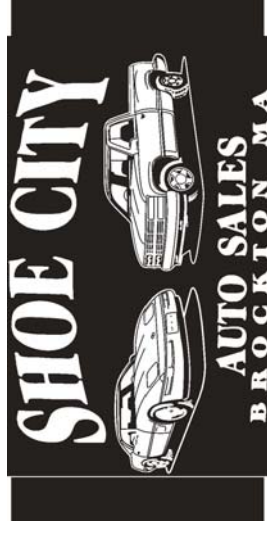
